Proposition #1:

Shall the proposed budget of \$26,386,330 for the Sandy Creek Central School District, Oswego County, New York as recommended by the Board of Education for the fiscal year begining July 1, 2023, be adopted and shall the Board of Education be authorized to levy the necessary tax thereof?

Proposition #2:

Pursuant to Education Law §259 the Board of Education of the Sandy Creek Central School District is authorized to levy and collect an annual tax, year after year, separate and apart from the annual school district budget, the additional amount of \$30,000 (above the current amount of \$149,000 for a total of \$179,000), which shall be paid to the Annie P. Ainsworth Memorial Library (\$25,000 for a total of \$150,000), and the Cogswell Free Library (\$5,000 for a total of \$29,000) for the support and maintenance of the libraries; with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Sandy Creek Central School District.

A Message From Sandy Creek:

With spring upon us, we are excited for the increase in temperature, the decrease in snow, and the ability to engage in all the activities that come with warmer weather. This time of year is similar for all of us as we are getting outside to prepare lawns and fields, and clean up from the winter. At this time of year, we begin to plan for the summer and the following school year by looking at schedules and staff to meet the ever-changing needs of our students here at Sandy Creek.

Throughout this school year, we have maintained our efforts of meeting the needs of the students while looking toward future endeavors. We have highlighted some of those fundamental instructional practices that all students require, while putting a critical lens on the social-emotional learning of our students. Our efforts across the district have and will continue to focus on what is best for your students. We are to the point that using COVID-19 as an excuse is no longer valid. Our energy is now on a solution-focused approach to provide support across the district.

In preparing for the 2023-2024 school year, you will be voting on an expenditure plan on May 16, 2023. The Board of Education and the administration have worked to develop a fiscally responsible budget that takes our current situation and future projections into account. Financially, the district is in a stable position where it can maintain staff and current systems that provide a clean and structurally sound environment. To continue to give students what they need and deserve, it is vital that we create fiscally responsible plans. As we all know, there are continuous increases in the cost of salaries, insurance, and the materials necessary to run the campus. The cost of most operational necessities has increased over the last couple years, so we need to plan for those increases. As a result, we will be asking for a modest 3.37% tax increase for the 2023-2024 school year. Conservatively, that would equal, at most, a \$16 increase in the tax on true (average) for a \$100,000 home. The Consumer Price Index that the state compares to our tax levy is 8%, which we know is much lower than the increase in the price of many items you regularly purchase.

At this point, we are still able to provide many extra opportunities due to the stimulus funds that have been provided. However, these opportunities, such as the elementary and middle school summer-school programs, the after-school program, and the staff hired to meet mental health needs of our students will be impacted once the funds run out. Our goal is to maintain the current status of programming across the district, but we need to plan financially for the future to ensure we can meet this goal.

On a different note, as the district moves forward this summer, we are hoping to finalize a majority of the capital improvement project that has taken place over the last several years. During the summer of 2023, many floors will be replaced, significant work will be done in the Middle/High School stair towers, much of the sidewalk encompassing the entire building will be replaced, and the parking lots will be milled and paved. We are excited to get this work completed to improve the safety of the district and update necessary parts as well.

We thank you for your continued support of our students, staff, faculty, and programming. We are consistently working together to create fiscally responsible plans that are forward thinking as society continues to evolve.
