SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The District has a Comprehensive District Education Plan (CDEP) Committee that is comprised of representatives of all of the Stakeholders (Board, Administration, Union, Parents, all departments including special education). Through discussions with these folks from the time of notice of the funds, through budget season and forward we have discussed the many requests for additional staffing to meet the needs of those impacted by the pandemic and constant low poverty of the district. The District also using CDEP as a base initiated a re-opening committee that included not only Education department folks but also all of the service related departments of Food, Transportation and Sanitary. These key stakeholders were the group that drove the plan.

They are aware of the CDEP committee that reports regularly at the Board of Education meetings. Updates are given regularly at all BOE and CDEP meetings.

With the addition of the extra staffing (interventionists), it will allow for increased social distancing. Our District was pretty much socially distanced prior to pandemic with small class sizes of 16 or less children per class with few exceptions. Those exceptions were tackled with interventionist and changing of common areas into dedicated classroom space. The classroom space dedication was at no additional cost. <https://www.sandycreekcsd.org/pub/1072> is the District's plan for reopening. There were no changes from the original plan with the exception for the 21-22 school year - ALL students are present everyday no hybrid remote with the only exception for those who are quarantined.

Our District implemented an in depth Academic Intervention Service (AIS) platform years ago. The AIS team has adapted our Continuity of Learning Plan to not only include our assessments (Dibels/Star etc) but to also include such materials and processes (ie portfolios) necessary to accurately monitor remote student progress through the pandemic. We are up to date on all students progress (with the exception of the few that are new to us from over the summer) and can hit the ground running with all services in place. We have assessed our incoming kindergarten over the summer and are go to go with them. We did not have pre-k last year and lost the whole year of early intervention with those students. We have an AIS plan in place to bring those students up to speed.

Sandy Creek held a **summer school program** for elementary K-5 this year off campus (because of construction) at Pulaski Elementary. We also combined with Pulaski to hold a summer school program for grades 6-12. All students were invited to attend with those in desperate need addressed personally to urge parents to allow their children to attend. Overall, the attendance was great and for the most part our students in severe need of intervention were present. Summer school programs are also planned for the next two years with the use of these funds. Additionally the District has undertaken a formal **After school extended day learning** for grades 2-12 for the upcoming and additional two years as well. The amount of community support was overwhelming. Our District is 200+ square miles, some students are on the bus for over an hour. Our fantastic Food Services Department has even applied for and was granted the opportunity through the USDA to feed our extended day learners not only a snack but also a full dinner before they depart our campus. Grades PK-1 will have extra interventionists throughout the day for extra support as we deemed the day would be too long for those who live in our rural areas.

We will use the remaining funds to address the social emotional impact of the pandemic through the hiring of a School Social Worker, School Psychologist and an additional Drug and Alcohol counselor. We believe that our students living in such a rural area, having been absent from school for such a long period of time has taken a toll on our students, especially those with terrible home circumstances. The increased funding will allow for more access to off-time (summer/afterschool) instructors and facilities. The facilities access is critical as our poverty level and extreme rural area prohibits students from having access to the internet at home. Those students that have access to cellular towers we provide internet hubs, however the majority of those without internet services do not have cellular reception. Therefore it is vital to have our school open after normal school hours.

Our school community is very small (under 800 students), we are housed on one campus. Our Superintendent as well as most of our employees know every student by name and face recognition. We excel on the difficult cases. Our Special Education Department operates on a inclusion model. Very few students are sent to off campus programs. We are a Community Eligible school for food services, meaning **ALL** of our students eat for free everyday, every meal or snack. Prior to the pandemic we had low income families, homeless and foster, students of color, English learners etc. Sandy Creek is well equipped with the fundamentals to provide services to these disproportionately impacted by COVID. With the use of the funding as expressed above we have made it a community decision and with the extra hands provided we will be ready to meet the needs of these students. The extra positions such as psychologist and interventionist will focus on those that were displaced in some manner from COVID. The District has school based intervention teams (SBIT) that discuss EACH child every month/Weekly by grade level. The SBI teams are not only for grade level in the elementary but also in the Middle and High School. The Special Education Department has their own SBIT for their students both IEP and 504. The principals of the District sit on these teams as well to ensure that no child is forgotten. When a new student is welcomed into the district a comprehensive review happens at SBIT. For the most part they are relatives of existing families in the District. Our District receives very few "new families". Each child is observed and discussed by the entire team. Our District recognizes that our campus is like a sanctuary to most students. We have very little if any vandalism, violence etc. Our culture is to meet every need of our students. We begin with feeding them 4 times a day (3 meals - breakfast, lunch and dinner for those that are here at 5:30, and an afterschool snack). During the meal times, all counselors are available for students. We have very few students of color and ELL's. Those students are treated like ALL of our students and we do not differentiate because of those specific identifiers. We are a small school of 780+/- ALL of our students are treated the same. Should one child be experiencing difficulties they are assigned interventionists and logs with time sheets are kept and reviewed at SBIT and in the District office. All hands on deck has been the theme for the past year and half.
