A Contract for Excellence

On Monday, January 29th, newly elected Governor Eliot Spitzer announced his plan for Education Reform.

I waited anxiously all day for the 2PM announcement. After reading a copy of his speech on the internet later that afternoon, listening to the news media that evening, and reading all the newspaper articles the next day, I finally think we have a Governor who really wants to improve education for all New York State students. He realizes that the main goal is to produce responsible citizens who have the tools to participate productively and meaningfully in the world around them and to be leaders of tomorrow in all areas of Culture, Science, Business, Service, and Government.

As Governor Spitzer stated in his address, "My vision for education reform is built on a single premise: to be effective, new funding must be tied to a comprehensive agenda of reform and accountability." I agree with this and will be first in line to make his vision a reality. As a School Superintendent, I have nothing to fear from increased accountability. We are already the most accountable school employees. That's all we have been asking for are the tools to deliver the results that we all seek.

I applauded his commitment to provide significant additional state aid to schools, especially those serving the needlest children like Sandy Creek and several other school districts in Oswego County. The Governor is also pledging a simplified funding system and multi-year commitment that will help all Superintendents and Boards of Education do their best planning and management.

Property Tax Relief is another major challenge in his plan for education Reform. His vision will not become a reality until we fix the burdensome and inequitable property tax system.

In summary, I want to recite a quote from his January 29th Education Speech, "A Contract for Excellence" that sums it up for me personally. Governor Spitzer states:

"The dynamic in education is about to change dramatically. With reform and accountability, we will propose in our upcoming Executive Budget, and the resources we will commit to fully fund our schools over the next four years, there will be no more excuses for failure. The debate will no longer be about money, but about performance; the goal will no longer be adequacy but excellence; and the timetable will no longer be tomorrow but today. And that is as it should be."

I finally feel that the Governor's Office wants to work hand in hand to improve education for our children.

This is the time of year when the Administration and BOE begins diving into the budget process for the 07/08 school year. The State's budget will be interesting this year with a new Governor and party at the helm in Albany. Political affiliations aside, NYS government has a lot of issues that need to be fixed. I want to reiterate that the BOE intends for this to be an open and transparent process. Also as a reminder, if any one has a desire to become involved in their community, nominating petitions for the BOE are available starting March 16th, as there are two positions that are up for re-election this year.

As I promised (or threatened) in the last article I am going to continue with the topic of "How can school boards improve student achievement." The following items are adaptations from an article by Carol Jeep in "On Board."

- Successful boards take advantage of training opportunities most of the available training for the BOE comes from the New York State School Board Association. This is an area where we need improvement. I admit it has been difficult to commit to the training as most events are held in Albany, the cost is not covered by our membership dues, and it has been hard to work around family events.
- Successful boards commit to high student expectations. Express them through statements of vision, mission and goals, and standards with a focus on improving student achievement for all students.
- Prioritize resources. Support ongoing training for staff, administrators, and board members.
- Expect high accountability. Measure and monitor. Set a schedule to examine various reports on meaningful academic indicators at least monthly.
- Align policy, planning and practice. Use data to inform decision-making.
- Commit to having a strong and productive board/superintendent relationship. Use retreats, training, board self-assessment and superintendent evaluation to make your governance team a true team.

• Cultivate mutually respectful relationships on the governance team. Communication, trust and understanding role differences are the foundation of good board/superintendent relationships and the most critical factors in determining how well a school system operates.

As I wrap this up for this edition, I'd like to personally invite you to attend our BOE meetings. At the January 11th regular board meeting the social studies department gave a very through presentation on how their methods of teaching both align with New York State Standards and kept the students interest while learning. On January 25th the Board of Education was really put to the test at their work session. Representatives of the art department presented not only an overview of their current course offerings but also challenged the board in a bit of their own creativeness. The drawings of each BOE member hand were quite exquisite! Again, we welcome you to attend our next board meeting(s). Not only will the budget be a topic of discussion but we will also have presentations from the following departments: Health/Physical Education and Languages other than English (Spanish & French).

PRE K AND KINDERGARTEN REGISTRATION AT SANDY CREEK CENTRAL SCHOOL

We will hold PreK and Kindergarten registration (for the 2007—2008 classes) on Wednesday, March 28, 2007. You must be a resident of the Sandy Creek Central School District and on or before December 1, 2007, your child must be 4 years old for PreK and 5 years old for Kindergarten to be eligible to start in September.

Registration hours are as follows:

12:30 - 2:00 P. M. at the Sandy Creek Elementary 6:00 - 7:30 P. M. School, in the Elementary Lobby.

Registration will be held at Sandy Creek Elementary School Lobby. You may come in to register at the time convenient for you. Your child does not need to attend registration with you. Prek information will be available regarding August health screening and September visitations. There will be visitation and testing dates for the incoming Kindergartners later in the spring.

Please bring your youngsters' birth certificate and immunization records to registration. Questions about immunization requirements may be directed to the school nurse. Other papers such as proof of residency or custody papers may be required at a future date. Be ready to sign up for a testing date in May if you are registering for Kindergarten. If you are unable to join us on March 28, you may call the elementary office to make other arrangements [387-5626 Ext. 1110].

For all PreK registrants: Please understand that this is the first step in the application process. Space is limited, and you must have <u>completed</u> information returned by **the end of the day March 28**th to move ahead in this process. It is important to fill out all the information, especially the transportation form. This information is needed to determine the A. M. and P. M. classes and the timing for the bus routes. If more than 36 students are signed up on March 28th, students will be picked from a lottery. If <u>less</u> than 36 students are signed up on March 28th, they will all be included at that time.

If you are new to the area and/or feel we may not have your child on our census list, please call the elementary office <u>now</u> [387-5626 Ext. 1110]. It is important that we have an accurate projection of kindergarten size for staffing and facility planning. Also, there are materials we would like to send you.

Facility Use at Sandy Creek

During the construction project a team was formed to look at procedures and policies needed for using the school building and fields. It was important to the team that we give access to as many groups/organizations as we possibly could. The first priority for usage is for school and school related activities. Priority 2 is community youth organizations and groups, Priority 3 is all other community organizations and groups, and finally Priority 4 is non-community and for-profit organizations.

Facilities that are commonly used are classrooms, the athletic fields and gymnasiums, the auditorium and the cafeterias. There is a cost associated with facility use which is reviewed by the team annually. Costs vary depending on priority and staffing. Priority 2 and 3 groups are charged \$20.00/hr for custodial assistance when coverage is not already scheduled. Priority 4 groups regardless of scheduled custodial coverage will be \$30.00/hr and a \$50.00 usage charge.

SOMETHING NEW!

The Sandy Creek community now has the ability to fill out a facility use request by way of the internet. We have recently purchased a program called School Dude. The program is being set up and will be available for the community shortly. Anyone interested in using the facility can find the necessary forms and policy in the high school and elementary school offices.

Dear Parent, Guardian, and School Staff:

New York State Education Law Section 409-H, effective July 1, 2001, requires all public and nonpublic elementary and secondary schools to provide written notification to all persons in parental relation, faculty, and staff regarding the potential use of pesticides periodically throughout the school year. The following pesticide applications took place in the Sandy Creek Central School from September 1,2006 to February 16, 2007:

There have been no pesticide applications during the above stated period.

As a reminder, the Sandy Creek Central School District is required to maintain a list of persons in parental relation, faculty, and staff who wish to receive 48-hour prior written notification of certain pesticide applications. The following pesticide applications are not subject to prior notification requirements:

- A school remains unoccupied for a continuous 72-hours following an application;
- Anti-microbial products;
- Nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children;
- Nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children;
- Silica gels and other nonvolatile ready-to-use pastes, foams, or gels in areas inaccessible to children;
- Boric acid and disodium octaborate tetrahydrate;
- The application of EPA designated biopesticides;
- The application of EPA designated exempt materials under 40CFR152.25;

_____Evening Phone:____

• The use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps, and hornets.

In the event of an emergency application necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48-hour prior notification list.

If you have not yet registered to receive 48-hour prior notification of pesticide applications that are scheduled to occur in your school, please complete the form below and return it to Shelley H. HEALTH FAIR! The Nurse's Office will be hosting a **Health Fair** for Grades 6-12, on **March 15th**. We will be focusing on healthy habits including nutrition and exercise. We will also have information about drug abuse, smoking habits, character education and more. It will be held from 10am- 1pm in the hallway outside the cafeteria so students can view the information during their lunch time. If all goes well we hope this will become an annual event for the students.

FREE EYE GLASSES? Did you know that the School Nurses participate in a Vision Eye Glass Plan called "Sight for Students"? If your child does not have any other vision insurance coverage (including Medicaid) and needs an eye exam from an eye care specialist, he/she can get a gift certificate from either of the School Nurses. The participating providers are Drs. Dexter and Baker who have an office in Pulaski. Your student can receive a free eye exam and free glasses if indicated. This is a wonderful service provided for our Sandy Creek students through the National Association of School Nurses and by our school district. Please call our office if you have any questions.

ELEMENTARY "BMI" PROJECT We have started a long term study with our elementary students in the areas of height, weight, and BMI calculations to determine if there are students that may be showing tendencies toward an unhealthy body weight. **BMI, or Body Mass Index**, tells if a person may be overweight or underweight. It is a screening test. Doctors use screening tests to find problems early. Every elementary student has had a BMI calculated for them at the time of regular health screening. Monitoring the BMI each year may help prevent more serious health problems from developing later. Contact us if you would like to discuss your child's BMI.

News from our Special Education Department

There have been many recent changes in policy and regulations at the State level that will impact Students With Disabilities. School districts will be expected to maintain the same rigorous standards for these students as they do for their typical peers. At Sandy Creek, we are ahead of the game on many fronts. Our program is fully inclusive with a minimal number of students receiving services outside of the general education setting. This provides us with an excellent base on which to build an even more rigorous program that should result in increased numbers of Students With Disabilities receiving local and Regents diplomas as they exit high school.

The changes that are occurring are based in part on the federal laws that help ensure that children with disabilities receive services they need. These laws include the No Child Left Behind Act of 2001 (NCLB) and Individuals with Disabilities Education Improvement Act of 2004 (IDEA).

NCLB ensures that every student receives a high-quality education. Its goals are to challenge and motivate students, provide highly qualified teachers (including special education teachers) who use proven teaching methods and ensure a safe, drug-free learning environment. Under NCLB, an assessment system is used to ensure that all children are learning.

IDEA is the nation's special education law. It allocates money to the states to provide special education and related services to eligible students with disabilities. These services are provided at the pre-school and school age level. IDEA requires that a special team of educators and other professionals involved in a student's individual education plan determine how the child is assessed.

STAR Program May Lower Property Taxes: Have you filed your application?

Lower school taxes result from the homeowners who participate in the state's School Tax Relief (STAR) Program. STAR provides primary residence homeowners with a reduced assessment.

There are two STAR programs, as follows:

BASIC:

All eligible homeowners

Exempts first \$30,000 approximately [06-07 ranges of \$26,220 - \$34,230 specific by town] (full value) of assessment for school tax purposes

ENHANCED:

For homeowners 65+ years of age

Income for STAR purposes less than \$66,050

Exempts first \$50,000 approximately [06-07 ranges of \$49,640 - \$64,810 specific by town] (full value) of assessment for school tax purposes

Must be renewed annually

Cannot be combined with Basic STAR

Q. How do I get my Basic STAR tax cut?

A. You must file an application with your town assessor. The application has been made as simple as possible. Property owners who are granted the Basic STAR exemption generally will not need to reapply in subsequent years because the Basic STAR exemption is granted regardless of income. However, Basic STAR recipients will need to notify their assessor if their primary residence changes.

Q. Where do I get the STAR application?

A. Star applications are available from your town assessor, your county real property tax office, or on the internet.

Q. Is there a deadline by which I must file the application form?

A. Yes. The deadline for applications is March 1st.

Q. Where do I file the STAR application form?

A. With your town assessor. The application is processed locally, not by the State. Do not file the application with the State Office of Real Property Services, the Governor's Office, your school district, or any other State agency.



To: Parents & Community Members,

As part of the No Child Left Behind Legislation, the Federal Government, along with the New York State Education Department, is evaluating schools on both their participation and/or performance on New York State Exams. You might have recently seen an article or heard that Sandy Creek High School is a School in Need of Improvement "SINI". This information is correct. The high school was placed on the state list for participation, not performance. We did not have enough of our graduating seniors take the Math A Regents exam or the Math Regents Competency Test during the 2004-2005 school year. The annual state cut off point is 95% for class participation. Sandy Creek's participation rate was 94.4% for 2004-2005. This means that out of the 73 seniors that graduated in 2005, 68 of them took a Math exam. The remaining 5 students did not because it was not a requirement for their special education individualized plan.

Once a school is designated as a School in Need of Improvement (SINI), the school must demonstrate adequate yearly progress for two consecutive years to be removed from SINI status. The Sandy Creek High School is currently in the second year of this status. During the 2005-2006 school year, we made progress, and according to recently released results, our participation rate for both Math A and English 11 was at 97%. All of our students regardless of what diploma they are striving for will attempt the Math A exam or an Alternative Assessment. We will be on the SINI list for the remainder of the current school year, but have made positive progress. We will continue to do what is necessary to regain good standing by the beginning of the 2007-2008 school year.
