It was moved by Soule, seconded by Haynes, to approve the following resolution: **OSWEGO BOCES Budget Resolution:** At a special meeting of the Board of Education ("Board") of the Sandy Creek Central School District, Oswego County, New York (the "District") held at the District Office in the Town of Sandy Creek, New York on the 24<sup>th</sup> day of April, 2019.

The meeting was called to order by Brian MacVean, Board of Education President, and upon roll being called, the following were:

WHEREAS, the Board desires to approve said tentative administrative budget.

## Section 2

This Resolution shall take effect immediately.

## **Discussion:**

The Board of Education discussed the 19-20 Budget with Kyle Faulkner, Superintendent of Schools and Shelley Fitzpatrick, Business Administrator. The following motions were made:

It was moved by Soule, seconded by Dowlearn to put forth an expenditure plan that included a 3% tax levy increase inclusive of not replacing the High School Principal position.

It was moved by Shelmidine, seconded by Hathway to put forth an expenditure plan that included a 3.5% tax levy increase.

<u>4</u> yes, <u>3</u> no (Soule, Dowlearn, Metott), <u>0</u> absent Motion carried

## ACTION ITEMS:

It was moved by Shelmidine, seconded by Hathway, to approve the following resolution: RESOLVED, upon the recommendation of the Superintendent, to approve the **Instructional Expenditure Plan for the 2019-2020 school year** at a stated amount of \$ 23,026,551.

Motion carried

Ms. Metott noted that her vote of no was that the District has been using reserves to get by and that very shortly those reserves will be exhausted. Therefore, Ms. Metott would have supported a higher tax levy increase.

Mr. Dowlearn also stated that he would have approved up to a 4% increase in the levy as long as the HS principal position was not replaced.
