It was moved by Warner, seconded by Macklen, to approve the following resolution: RESOLVED, upon the recommendation of the Superintendent, to approve the following agreement as follows:

This agreement is made by and between the Sandy Creek Central School District ("District") and the Sandy Creek Central School District Administrators Association (the "Association"), together, the Parties.

WHEREAS, the District wishes to create the title of Assistant Principal and add it to the Association collective bargaining agreement as a recognized title covered by the SCAA CBA; and

WHEREAS, the District and the Association agree that the title of Assistant Principal, if created, should be a title covered by the SCAA CBA.

NOW, THEREFORE, the District and the Association agree as follows:

1) Article 2 <u>Recognition</u> clause of the CBA shall be modified by ADDING the following language in Section 2.1 Unit Definition:

The Sandy Creek Board of Education (the "Board" recognizes the Sandy Creek Administrators Association (the "Association") as exclusive bargaining agent and representative for all administrators in the Sandy Creek Central School District (the

"District") to include all Principals, Assistant Principals, Director of Curriculum & Instruction (DCI) and the Director of Facilities (DOF)3.

2) The Parties acknowledge that the CBA modifications included in this memorandum of agreement shall take effect only after legislative ratification of the Sandy Creek Board of Education.

James will begin his tenure of four years on the date of issuance of his administrative certification. James's annual salary base will be \$96,500 to begin July 3, 2023. James will also carry with him the accumulated sick time of approximately 94 days.
